

SCHOOL TRANSPORT FACILITY



To ensure safe travel the school has its own fleet of school buses designed as per standards and manned by trained drivers and personnel sensitized to the needs of small children. The Transport Service (Optional) is operated by the school and a separate transport fee is charged for this. The School provides transportation facility to students for Noida Sector -15, Sector-15 A , Sector- 12/22, Ashok Nagar, Sector – 44/45 Chhalera. The buses have limited stops to ensure timely arrival at school and reducing the travel time taken by students.

The school buses follows all safety norms i.e. CCTV, Fire Extinguishers, emergency exit and experienced staff. Each bus has staff that includes Driver, Helper and a School Teacher till the last Stop. For supervision and monitoring a transport attendant is on the board throughout the journey. Emergency Phone numbers have been provided in each bus that ensures efficiency in terms of service and better communication in case of emergencies. Besides ensuring the implementation of the safety norms, all staff on the bus is well trained in first aid and emergency management. The school has been designed with an internal periphery road where buses are parked and students board and alight from the buses inside the school campus.

JOINING, CHANGE AND WITHDRAWAL

- Admission to school does not ensure a seat on any particular bus. If a bus is full, or does not cover the required area, parents will have to make their own arrangements.
- For joining the School bus: To avail of the transport facilities parents are requested to fill up the form available in the office.
- Change of the School bus: Students must inform the office about the change of their bus route by filling up the prescribed form. The change must be endorsed on the Identity Card. No change will be effective unless sanctioned by the transport office.

- For discontinuation of the school bus: Inform the school office by submitting application. Bus fee will be charged till the office is informed.
- Parents must verify the credentials of the drivers and the road worthiness of the vehicles if their wards are using private school vans/taxis.
- Every student's mode of transport should be recorded in the school office and on the Identity Card.

Rules Governing Transport Facility

- The school has taken utmost care for the safety and convenience of the students.
- Transport service is an optional service facilitated and outsourced by the school for the convenience of its students.
- Any suggestion at any point of time applicable to School Transport be forwarded on school Email id : nsps26@yahoo.in
- The buses will not wait for latecomers.
- Boarding and alighting from buses should be done in silence and in an orderly manner.
- No student should travel standing on the footboard.
- Students must make not move around in the bus when it is in motion.
- The students must make sure that the aisle of the bus is clear, school bags and other belongings are placed properly.
- Students must not put any part of their body outside the bus. They should not put their hands out even for waving.
- No object should be discarded inside or thrown outside the bus.
- Consumption of edibles is not permitted in the buses.
- Unruly behaviour 'like shrieking, shouting and playing foul is strictly prohibited. Courteous behaviour is expected at all times.
- A student shall be refused the bus facility if involved in damage to the bus property. Besides, the damage done will have to be compensated by the student.
- Any change in the bus timings will be notified to the parent by the school.
- Students will have to board and alight the school bus at the respective stops allotted to them only.
- Students while traveling on the school bus must maintain discipline. Any student guilty of misconduct will not be allowed to avail the bus facility.
- Students / parents will not have any transactions / altercation / physical fight with the bus staff.
- Under no circumstances are students allowed to go behind or under the parked buses within the school campus. Students are also not allowed to sit in the parked buses during school hours.
- Under no circumstances, should students touch the instrument panel of the buses.
- It is important that any change to the usual pick-up / drop routine is intimated to the transport in charge a day in advance. Bus crews have been instructed to bring back to the school any student who is not collected by the authorized person at the designated bus stop.
- No child will be handed over to an unknown person/ to anyone without the parent I-card which must be produced at the time of pick up.
